AMENDMENT ORDER (NO.X) 20XX**

**THE SURREY COUNTY COUNCIL** (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 36, 45, 46, 49, 51 and 53 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**1. THIS** Order may be cited as "The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions Street Parking Places and Revocation) Amendment Order (No.X) 20XX" and shall come into operation on **XX XXX 20XX**.

**2. ANY** reference in this order to any enactment means any enactment whether public general or local and including any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment and shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

**3. WITHOUT** prejudice to the validity of anything done or to any liability incurred in respect of any act of omission before the coming into operation of this Order The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone)(Consolidation of Waiting and Loading Restrictions and Street Parking Places and Revocation) Order 2009 shall have effect as though:

- (a) in sub-paragraph (c) of paragraph 9 of Article 92 of that Order in the first line thereof for the figure "273" there was substituted the figure "316"
- (b) in paragraph 4 of Article 106 of that Order in the second line thereof for the text "thirty per annum" there was substituted the text "sixty per annum"
- (c) for the Third Part of The Schedule to that Order there was substituted the Third Part set out in The First Schedule to this Order
- (d) for the Fourth Part of The Schedule to that Order there was substituted the Fourth Part set out in The Second Schedule to this Order.

## THE FIRST SCHEDULE

### THIRD PART

#### SCALE OF CHARGES PAYABLE IN RESPECT OF ANY MOTOR VEHICLE LEFT IN A PAY AND DISPLAY PARKING PLACE AND DUAL USE PARKING PLACE (SEE ARTICLE 32)

- (i) The charge for a motor vehicle left in any Pay and Display and the Dual Use parking places situated in the roads specified below during the permitted hours as defined in paragraph (1) of Article 2 (in this particular case for the avoidance of doubt the period between 8.30 a.m. and 6 p.m. on Mondays to Sundays inclusive) shall be one pound for a period of thirty minutes or during the permitted hours as defined in paragraph (1) of Article 2 (in this particular case for the avoidance of doubt the period between 6 p.m. and 9 p.m. on Mondays to Sundays inclusive) one pound for any period of waiting within that period without time limit:

#### **Roads where maximum stay in parking place is 30 minutes:**

Chertsey Street	Quarry Street
High Street	Ward Street
North Square	Woodbridge Road

- (ii) The charge for a motor vehicle left in any of the Dual Use parking places situated in the roads specified below during the permitted hours (in this particular case for the avoidance of doubt the period between 8.30 a.m. and 9 p.m. on Mondays to Sundays inclusive) shall be sixty pence for a period of not more than thirty minutes up to a maximum three pounds sixty pence for a period of not more than three hours:

#### **Roads where maximum stay in parking place is 2 hours:**

- (iii) The charge for a motor vehicle left in any of the Dual Use parking places situated in the roads specified below during the period (Monday to Sunday) 8.30am to 9pm permitted hours shall be sixty pence for a period of not more than thirty minutes up to a maximum of three pounds sixty pence for a period of not more than three hours:

**Roads where maximum stay in parking place is 3 hours:**

Castle Hill

Harvey Road

Pewley Hill
