# GUILDFORD ON-STREET PARKING MANAGEMENT REVIEW PROPOSED AMENDMENTS TO THE GUILDFORD TOWN AREA OUTSIDE OF THE GUILDFORD TOWN CENTRE CONTROLLED PARKING ZONE

**NOTICE IS HEREBY GIVEN** that Surrey County Council proposes to make an Order under Sections 1, 2, 4, 32, 35 and 36 and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') the effect of which will be to further amend "The Surrey County Council Various Roads in the Borough of Guildford Town Area Outside of the Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting Restrictions Street Parking Places and Revocation) Order 2004". The Order, to be known as "The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Area Outside of the Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting Restrictions Street Parking Places and Revocation) Amendment Order (No.X) 20XX" proposes to make the changes as described below.

The general purpose and effect of the Order will be to:

- (a) introduce new At Any Time waiting restrictions, Monday to Friday 8am to 10am & 2.30pm to 4.30pm No Stopping School Keep Clear Markings, and Limited Waiting 2 Hours No Return within 4 Hours Monday to Saturday 8.30am to 6pm free parking places,
- (b) introduce a Disabled Persons' Free parking place for use by any disabled persons' vehicle displaying a disabled persons' blue badge,
- (c) provide that in the lengths of roads referred to in paragraph (a) above that, in respect to waiting restrictions, the usual exemptions for loading and unloading vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining those lengths of roads and the services in them and for disabled persons' vehicles in accordance with the "Blue Badge" Scheme would apply,
- (d) in respect to paragraph (b) above, any vehicle may wait in that parking place for the purposes of boarding and alighting (for a period not exceeding two minutes), or for the purpose of loading or unloading goods (for a period not exceeding twenty minutes).
