## **SURREY COUNTY COUNCIL - BOROUGH OF GUILDFORD**

## EXTENSION TO THE HOURS OF CONTROL IN CATCHMENT AREAS A, B AND D SITUATED WITHIN THE GUILDFORD TOWN CENTRE CONTROLLED PARKING ZONE AND CONSEQUENTIAL CHANGES TO CERTAIN OF THE EXISTING PARKING CHARGES IN THOSE AREAS

- 1. ON TUESDAY 21 SEPTEMBER 2021 SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") MADE, in part and with modification, The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions Street Parking Places and Revocation) Amendment Order (No. 2) 2021 ("the Order of 2021") under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 36, 45, 46, 49, 51 and 53 of and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act"), Regulation 19 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (S.I. 1996/2489) and of all other enabling powers, the purpose and effect of which is to -
- (a) extend the operational hours of all the various types of on-street parking places (including those parking places referred to in sub-paragraphs (b) and (c) below) and all the current waiting restrictions that apply on Mondays to Saturdays 8.30 am to 6pm within Catchment Areas A, B and D situated within the Guildford Town Centre Controlled Parking Zone ("CPZ") to Mondays to Sundays 8.30 a.m. to 9 p.m.; and
- (b) amend the charges for a vehicle which is left in any of the 30 Minute Only Pay and Display Parking Places situated in Chertsey Street, Quarry Street, High Street, Ward Street, North Square and Woodbridge Road, Guildford so that -
  - (i) during the period between 8.30 a.m. and 6 p.m. on Mondays to Sundays inclusive to impose a further charge and to amend the existing charge to one pound for a period of thirty minutes; and
  - (ii) during the period between 6 p.m. to 9 p.m. on Mondays to Sundays inclusive to impose a new charge of one pound per visit (with no time limit) at each such separate pay and display parking place; and
- (c) in respect of all the Dual Use Parking Places situated within Catchment Areas A, B and D within the Guildford Town Centre CPZ to extend the hours when the current charge applies from 8.30 a.m. to 6 p.m. on Mondays to Saturdays inclusive to 8.30 a.m. to 9 p.m. on Mondays to Sundays inclusive (for the avoidance of doubt there will be no increase in the amount of charge or the maximum initial periods of either two or three hours (as appropriate) at those parking places).
- 2. The County Council has -
  - (a) already introduced certain of the proposals contained within the Order of 2021 when that Order was originally proposed to be made (briefly, the introduction of two disabled persons' on-street parking places in certain lengths of Artillery Terrace and Martyr Road, an increase in the number of residents' parking permits issued in Catchment Area D and an increase in the number of visitor scratch-card permits that households within all Catchment Areas situated within the Guildford Town Centre CPZ can apply for) by the making of The Surrey County Council Various Roads in

- the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions Street Parking Places and Revocation) Amendment Order (No. 1) 2020 ("the Order of 2020") which was made on Wednesday 30 September 2020 and which came into operation on Wednesday 7 October 2020; and
- (b) decided not to proceed with the proposed extension of the operational hours of the various on-street parking places and any waiting restrictions that currently apply Mondays to Saturdays 8.30 am to 6pm situated within certain parts of Catchment Area C to Monday to Sunday 8.30am to 9pm. Therefore the operational hours of the affected parts of Catchment Area C situated within the Guildford Town Centre CPZ will remain as they currently apply and will NOT be extended to Monday to Sunday 8.30am to 9pm at any time in the foreseeable future.
- 3. A copy of the Order of 2021, which will come into operation on Monday 1 November 2021, together with Plans showing the lengths of roads and the Catchment Areas within the Guildford Town Centre CPZ to which that Order relates, a Statement of the County Council's reasons for making the Order of 2021, The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions and Street Parking Places and Revocation) Order 2009 ("the Order of 2009") (and the Orders which have previously amended that Order) (and the plans which accompany all of those Orders) and Regulation 19 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 may be inspected, free of charge, for a period of six weeks from Friday 24 September 2021 -
- (i) by prior arrangement and appointment only at Guildford Borough Council's Parking Office situated at Bedford Road Multi-storey Car Park (Level 2), Laundry Road, Guildford (Telephone No. (01483) 505050 or Email: <a href="mailto:Parking@guildford.gov.uk">Parking@guildford.gov.uk</a>) during normal office hours; or
- (ii) at Guildford Library, 77 North Street, Guildford on Mondays to Fridays inclusive between 9.30 a.m. and 5.30 p.m. and on Saturdays between 9.30 a.m. and 5 p.m.; or
- (iii) at Ash Library, Ash Street, Ash (Near Aldershot) on Tuesdays Thursdays and Fridays between 10 a.m. and 1 p.m. and 2 p.m. and 5 p.m. and on Saturdays between 10 a.m. and 4 p.m.; or
- (iv) at Horsley Library, Station Parade, Ockham Road South, East Horsley on Tuesdays Thursdays and Fridays between 10 a.m. and 1 p.m. and 2 p.m. and 5 p.m. and on Saturdays between 10 a.m. and 1 p.m.; or
- (v) by prior arrangement by telephoning or emailing the County Council's Merrow Complex situated at Merrow Lane, Merrow, Guildford, Surrey, GU4 7BQ (Telephone No. 0300 200 1003) or Email: highways@surreycc.gov.uk) between 9 a.m. and 5 p.m. on Mondays to Thursdays inclusive and 9 a.m. and 4.30 p.m. on Fridays.
- (NOTE A copy of the Order of 2021 as originally proposed to be made and the Order of 2020, together with a copy of the Notices, the Statements of Reasons and the Plans relating to that proposed Order and the Order of 2020 and the above-mentioned Order of 2009 (and the Orders which have previously amended that Order) (and the plans which accompany each of those sealed Orders) will also be held on deposit at the Guildford Borough

Council's Parking Office and the County Council's Merrow Complex and at Guildford, Ash and Horsley Libraries at the addresses and during the hours specified above, together with the documents specified above in paragraph 3 of this Notice).

4. If you wish to question the validity of the Order of 2021 or of any provision contained in it on the grounds that it is not within the powers conferred by the 1984 Act, or on the grounds that any requirement of the 1984 Act or of any Instrument made under it has not been complied with in relation to the Order of 2021, you may, within six weeks from Tuesday 21 September 2021, apply to the High Court for this purpose.
