# **SURREY COUNTY COUNCIL - BOROUGH OF GUILDFORD**

# AMENDMENTS TO ON-STREET PARKING PLACES AND WAITING RESTRICTIONS IN CERTAIN LENGTHS OF ROADS AND INTRODUCTION OF PAY BY PHONE TECHNOLOGY WITHIN THE GUILDFORD TOWN CENTRE CONTROLLED PARKING

## **ZONE**

1. ON THURSDAY 23 SEPTEMBER 2021 SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") MADE, with modification, The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions Street Parking Places and Revocation) Amendment Order (No. 3) 2021 under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 36, 45, 46, 49, 51 and 53 of and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act"), Regulation 19 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (S.I. 1996/2489) and of all other enabling powers, the purpose and effect of which is to:-

## (a) convert -

- (i) those parts of the existing Permit Holders F Only Parking Places operating between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive fronting Nos. 58 to 64 Agraria Road or No. 6 Mountside to a prohibition on the waiting by vehicles applying either at any time of the day or night throughout the week (double yellow lines) or between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive (single yellow line) respectively;
- (ii) certain parts of the existing Pay and Display (metered, ticket) or Permit Holders D Only Parking Place operating between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive situated in that length of the south-west side of South Hill which extends from a point 25 metres to a point 71 metres south-east of its junction with Castle Square to a prohibition on the waiting by vehicles applying at any time of the day or night throughout the week (double yellow lines);
- (iii) certain parts of the prohibition on the waiting by vehicles applying between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive (single yellow line) situated in that length of the north-east side of South Hill which extends from a point 13 metres to 71 metres north-west of its junction with Castle Hill to a prohibition on the waiting by vehicles applying at any time of the day or night throughout the week (double yellow lines);
- (iv) that length of the prohibition on the waiting by vehicles applying at any time of the day or night throughout the week fronting Nos. 57 to 61 Agraria Road (double yellow lines) to a Permit Holders F Only Parking Place operating between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive;
- (v) that length of the prohibition on the waiting by vehicles applying between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive (single yellow line) in that length of the north-east side of South Hill which extends from a point 20 metres to a point 60 metres south-east of its junction with Pewley Hill to a Pay and Display (metered, ticket) or Permit Holders D Only Parking Place operating between 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive;
- (b) alter the hours of control of the existing "shared-use" parking place with a 2-hour maximum stay, no return for 1 hour or for Resident Permit Holders H Only to a 1-hour maximum stay,

- no return for 1 hour or for Resident Permit Holders H Only situated in that length of the southwest side of Warwicks Bench which extends from 18 metres to 81 metres south-east of its junction with Castle Hill (NOTE- the hours of operation of the parking place will remain the same, i.e., 8.30 a.m. and 6 p.m. on Mondays to Saturdays inclusive);
- (c) in respect to sub-paragraphs (a) (i), (ii) and (iii) above, to provide that, in respect to the lengths of roads referred to therein, the usual exemptions for loading and unloading vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining those lengths of roads, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the "Blue Badge" scheme will apply;
- (d) in respect to sub-paragraphs (a) (iv) and (v) above, any vehicle may wait in those parking places for the purposes of boarding and alighting (for a period not exceeding two minutes), or for the purpose of loading or unloading goods (for a period not exceeding twenty minutes), etc.:
- (e) introduce pay by phone technology into Catchment Areas A, B, C and D of the Guildford Town Centre Controlled Parking Zone.
- 2. The County Council has deferred for further consideration the proposals contained in the Order referred to in paragraph 1 above as originally proposed to be made to introduce electric vehicles' on-street parking places in certain lengths of Benbrick Road, Jenner Road, London Road, Millmead, Pewley Hill, Quarry Street and Wodeland Avenue. Therefore, these electric vehicles parking places will not be introduced for the time being and will remain as either 30 minute or 2-hour, no return within 1 hour, Pay and Display (metered, ticket) Parking Places, a Permit Holders F Only Parking Place or an "all-comers" 2-hour maximum stay, no return within 1 hour or Permit Holders J Only Shared-Use Parking Place, all currently operating between 8.30 am to 6pm on Mondays to Saturdays inclusive at the present time, but may be so introduced within the next twenty-two months.
- 3. A copy of the Order, which will come into operation on Tuesday 2<sup>nd</sup> November 2021, together with ten Plans showing the lengths of roads to which that Order relates, a Statement of the County Council's reasons for making the Order, the Order of 2009 (and the Orders which have previously amended that Order) (and the plans which accompany all of those Orders) and Regulation 19 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 may be inspected, free of charge, for a period of six weeks from Friday 24 September 2021 -
- (i) by prior arrangement and appointment only at Guildford Borough Council's Parking Office situated at Bedford Road Multi-storey Car Park (Level 2), Laundry Road, Guildford (Telephone No. (01483) 505050 or Email: <a href="mailto:Parking@guildford.gov.uk">Parking@guildford.gov.uk</a>) during normal office hours; or
- (ii) at Guildford Library, North Street, Guildford on Mondays to Saturdays inclusive between 10 a.m. and 4 p.m.;
- (iii) at Ash Library, Ash Street, Ash (Near Aldershot) on Tuesdays, Thursdays, Fridays and Saturdays between 10 a.m. and 2 p.m.;
- (iv) at Horsley Library, Station Parade, Ockham Road South, East Horsley on Tuesdays, Thursdays, Fridays and Saturdays between 10 a.m. and 1 p.m.

- (NOTE A copy of the made Order referred to in paragraph 1 above as originally proposed to be made, together with a copy of the Notice, the Statement of Reasons and the Plans relating to that proposed Order and the Order of 2009 (and the Orders which have previously amended that Order) (and the plans which accompany each of those sealed Orders) will also be held on deposit at the Guildford Borough Council's Main Reception and at Guildford, Ash and Horsley Libraries at the addresses and during the hours specified above, together with the documents specified above in paragraph 3 of this Notice).
- 4. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the 1984 Act, or on the grounds that any requirement of the 1984 Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within six weeks from Thursday 23 September 2021, apply to the High Court for this purpose.
