GUILDFORD ON-STREET PARKING MANAGEMENT REVIEW MADE AMENDMENTS TO THE PARISHED AREAS WITHIN THE BOROUGH OF GUILDFORD AMENDMENT ORDER (No. 2) 2021

NOTICE IS HEREBY GIVEN that Surrey County Council has made an Order under Sections 1, 2, 4, 32, 35 and 36 and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') the effect of which is to further amend "The Surrey County Council Various Roads in the Parished Areas within the Borough of Guildford (Consolidation of Waiting Restrictions and Street Parking Places) Order 2004". The Order, known as "The Surrey County Council Various Roads in the Parished Areas within the Borough of Guildford (Consolidation of Waiting Restrictions and Street Parking Places) Amendment Order (No.2) 2021" makes the changes as described below.

The general purpose and effect of the Order will be to:

- (a) introduce No Waiting At Any Time waiting restrictions,
- (b) provide that in the lengths of roads referred to in paragraph (a) above that, in respect to waiting restrictions, the usual exemptions for loading and unloading vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining those lengths of roads and the services in them and for disabled persons' vehicles in accordance with the "Blue Badge" Scheme will apply.

NO WAITING AT ANY TIME

Chester Close, Ash (north side, from 10-15 m west of the end of the road (opposite No. 3)

Winchester Road, Ash (east to west arm, south side, from 18m to 30m west and 18m to 30m east of its junction with the north to south arm of Winchester Road)
