THE SURREY COUNTY COUNCIL (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and 36 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1. THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Area Outside of the Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting Restrictions Street Parking Places and Revocation) Amendment Order (No.2) 2021" and shall come into operation on **2nd Novemeber 2021**.

2. THE Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Area Outside of the Guildford Controlled Parking Zone) (Consolidation of Waiting Restrictions Street Parking Places and Revocation) Order 2004 shall have effect as though:
