D) Public Nuisance Description	Doors and windows kept closed where possible to reduce noise. Customers encouraged to leave quietly and respect neighbours. Regular litter collection and waste disposal to keep the area clean. Deliveries and collections scheduled to minimise disturbance.
E) Protection Of Children Description	No alcohol on the premises. Challenge 25 policy in place for age-restricted products (if applicable). Staff trained to identify and refuse service to underage or vulnerable persons. Children must be accompanied by an adult during late hours.
