B) Prevention Description	<p>CCTV System – Install and maintain high-quality CCTV inside and outside the premises, ensuring footage is retained for at least 31 days and accessible to the police upon request.</p> <p>Staff Training – Train all staff on responsible alcohol sales, conflict resolution, and how to identify intoxicated or underage customers.</p> <p>Challenge 25 Policy – Enforce strict age verification by requiring valid photo ID (passport, driving licence, PASS card) for alcohol sales.</p> <p>Refusal Log & Incident Book – Keep a record of refused sales and incidents, including unruly behaviour, drug-related issues, and intervention actions.</p> <p>Door Supervisors (if required) – Use SIA-licensed security staff for crowd control during busy hours.</p>
C) Public Safety Description	<p>Fire Safety Compliance – Conduct regular fire risk assessments, ensure clear exit routes, and provide fire extinguishers and alarms.</p> <p>Capacity Management – Monitor maximum occupancy levels to prevent overcrowding.</p> <p>First Aid Equipment & Training – Keep a fully stocked first aid kit on-site and ensure staff are trained in basic first aid.</p> <p>Glass & Bottles Management – Use plastic cups where necessary and implement safe disposal of glass to prevent injuries.</p> <p>Health & Safety Risk Assessment – Regularly review potential hazards (e.g., wet floors, trip hazards, electrical safety).</p>
D) Public Nuisance Description	<p>Noise Control:</p> <p>Install soundproofing and keep doors/windows closed after a certain time.</p> <p>Adjust music levels to comply with Environmental Health noise limits.</p> <p>Display “Please Leave Quietly” signs to remind customers to respect neighbours.</p> <p>Waste Management</p> <p>Provide sufficient bins inside and outside the premises.</p>

	<p>Ensure regular waste collection and avoid late-night disposal that may cause noise.</p> <p>Control of Customer Behaviour</p> <p>Assign staff or security to monitor outside areas, ensuring no excessive noise, loitering, or disturbances.</p> <p>Restrict smoking areas and prevent customers from taking drinks outside where not permitted.</p>
E) Protection Of Children Description	<p>Challenge 25 Age Verification Policy:</p> <p>Train staff to request valid photo ID for anyone who looks under 25.</p> <p>Use an electronic till prompt for age-restricted sales.</p> <p>Preventing Underage Sales</p> <p>Keep a Refusal Log to record any attempts by minors to purchase alcohol.</p> <p>Ban individuals who persistently attempt underage purchases.</p> <p>Safeguarding Measures</p> <p>Ensure staff are trained to recognize and report child exploitation or concerns.</p> <p>Prohibit unaccompanied children after a certain time (if applicable).</p> <p>Alcohol-Free Family Areas</p> <p>Clearly designate family-friendly spaces where alcohol is not served.</p>
