A) General - all four licensing objectives	We will maintain staff training on the sale of alcohol, a comprehensive CCTV system, manage our capacity, ensure monitoring of guest consumption of alcohol and act accordingly if excessive or inappropriate behaviour occurs. We will keep music to a minimal level.
B) Prevention of Crime and Disorder	CCTV in action and stored for the required time. Training staff on risk management and appropriate alcohol sales, and how to escalate or receive support if required. All alcohol sales must be accompanied with food purchase.
C) Public Safety	We have trained first aiders and a full first aid kit. Adhering to strict capacity limits to prevent overcrowding. Regular fire safety checks are completed including fire extinguishers
D) The prevention of public nuisance	No outdoor dining is available. Waste management occurs away from the building on a nearby road, by a reputable company. Music to a minimal level, monitoring of guest consumption and management where necessary. Utilising our town rangers or local services for support if required.
E) The protection of children from harm	Monitoring of ages of guests, and challenge 25 practice.
