					religion is very small – probably 1 request a year. At the present time we do not have land available for other religious sections within the Cemetery. If the person wishes to be buried within the Cemetery and is not one of the religions who already have a section the person may/can be buried in the Non-Conformist section. Some faiths use the extensive Brookwood Cemetry in the adjacent Woking Borough Council, this cemetery also provides for Muslim, green and woodland burials. Where possible flexibility of service provision has been extended to religious groups such as a Jewish Burial on a Sunday Memorial sizes are restricted, however to date we are not aware of this leading to differential impact.
