Guidelines

The Mayor's Award for Service to the Community recognises people and organisations who have gone above and beyond to serve the community and who have made a significant difference to the lives of our borough's residents.

- Mayor's Awards are given to recognise individuals or groups who have gone above and beyond to serve the community. We are looking for people who have made an outstanding contribution to life in Guildford.
- Mayor's Awards are given to recognise people who live or work in the borough, or organisations that are based and operate within the borough.
- Mayor's Awards can be awarded for paid or unpaid (voluntary) work. However, if you do nominate someone/an organisation for paid work, you must demonstrate how they have gone above and beyond what is typically expected from their job role. If you submit a nomination for someone which simply describes their job role, the nomination may not be eligible for a Mayor's Award.
- Mayor's Awards cannot be awarded posthumously or to organisations that are no longer in operation. An individual/organisation cannot win a Mayor's Award more than once, so please do not make nominations for people who have previously been given a Mayor's Award.

The nomination form is deliberately brief and simple to complete as we do not require lengthy submissions.

The following provides an idea of how nominations will be assessed, and you should consider these when completing the form:

1. What activities has the nominee undertaken?
2. Where do the activities take place and where do the beneficiaries come from?
3. How long has the nominee been undertaking those activities?
4. How often do the activities take place and how much time does the nominee devote to them?
5. How do the activities improve the community or the quality of life of its residents?
6. How many and what groups of people (e.g. older or younger residents) benefit from the activities?
7. How do the activities contribute to meeting local needs?
8. What personal strengths and skills does the nominee bring to their role?

Your personal information

Processing of your personal details is necessary to carry out a public task - which in this case is processing the nomination of the named nominee. We will always ensure that your information is held confidentially and accessed only by those people involved in processing the nomination.

Personal details of the nominee

Processing of the nominee's personal details is also necessary to carry out the public task - which in this case is the purpose of the conferring by us of any award. We collect the personal information necessary to process applications. This is with the purpose of making a determination of eligibility and suitability for an award. We may collect or receive sensitive personal data about a nominee. Such data includes personal data revealing ethnicity, disability or health conditions if this is part of the nomination story. Nominations should always be made in confidence. There is no requirement for the nominator to obtain the consent of the nominee.

The information you supply will only be used in relation to the Mayor's Award for Service to the Community and will be held by Guildford Borough Council for a maximum of two years. During this time, any information provided about the nominee may be shared with sponsors, judges or scheme administrators in order to assess the nominations. Details may also be passed to or published in the media for publicity purposes.
